WHEREAS, Employer is engaged in the retail computer business with a "Home Office" located at 124-B East Broad Street, Dunn, North Carolina, 28334 and has business relations with thousands of people; and,

WHEREAS, Employer and Employee have entered into and signed the "MLD Computers Employment Agreement"; and,

WHEREAS, Employee has acknowledged and agreed to the "MLD Computers Confidentiality and Non-Disclosure Statement"; and,

WHEREAS, if required Employee has acknowledged and agreed to the "MLD Computers Student Employment Agreement";

NOW, THEREFORE, it is agreed by and between the parties hereto as follows:

1. Employee agrees to record and keep and accurate and complete accounting of hours worked and tasks completed during those hours.
2. Employee agrees that all compensation will be paid based upon the accountancy of Paragraph One (1) and that Employer will hold no responsibility for compensation of time or activity not accounted for in writing.
3. Both parties agree that the rates set forth in this schedule are subject to review at either parties written request, or at no longer than a three-month (quarterly) interval. Written notes of any such review will be attached and kept with this agreement.
4. Both parties agree that if the rates set forth in this schedule are changed, a new "MLD Computers Compensation Schedule" will be completed, attached and kept with this agreement.
5. If Compensation is to be based on a "Salaried Position" complete Paragraph 5:
  - a. Employer agrees to pay a "Gross Salary" of USD\$ \_\_\_\_\_ per anum to Employee.
  - b. Both parties agree that the "Gross Salary" will be divided in equal payments of USD\$ \_\_\_\_\_ per week and paid at the close of business on Friday.
6. If Compensation is to be based on an "Hourly Rate" complete Paragraph 6:
  - a. Employer agrees to pay an "Hourly Rate" of USD\$ \_\_\_\_\_ per hour to Employee.
  - b. Both parties agree that the total of the weekly wages will be paid by Employer to Employee on a weekly basis, by the close of business on Friday.
  - c. Both parties agree that the work week will be calculated beginning Saturday and ending Friday.
  - d. Both parties agree that there will be no lapse of time between completion of Friday work and calculation and payment of the wage; adequate time will be scheduled each Friday to complete all accounting and bookkeeping required to satisfy Employee pay requirements.
